**NP: VITA TAX ASSISTANCE:** The Vance RAO will still complete income taxes until 15 Jul 20. PLEASE--NO WALK INS- Call 580-213-7859 or 580-548-5637 to set up an appointment to DROP OFF YOUR TAX DOCUMENTS. Be sure you have COMPLETED INTERVIEW SHEETS and you and spouse have signed the Form 14446 (Taxpayer Consent). IF NOT COMPLETED we cannot start the tax return. NOTE: TAX PACKAGES (TO INCLUDE INTERVIEW SHEET plus Form 14446) are available on the door to Room 102 in Building 200. MUST WEAR a mask because to drop off taxes and answer questions you may come within the 6 foot (social distance criteria) of the VITA volunteer.

They will be available once you log in to either HumanaMilitary.com website or the new Humana Military App for both Android and OS device. EOB's (Explanation of Benefits) will follow suit shortly and only be available digitally. Unsure of the transition date for EOB's. If you have the older Humana Military app please delete it and download the new app.

NP-STATE PARKS IMPLEMENT PARKING PASS FEE: The \$10 one time access fee began 15 June for most state parks. The parks offer a 100% discount for veterans who can prove it either through their retired ID, state driver license that indicates they are a veteran, or via the DD Form 214. The following state parks do not charge the \$10 parking pass: Alabaster Caverns; Black Mesa; Grand Lake's Bernice Area, Cherokee Area, and Spavinaw Area; Little Sahara, McGee Creek, Roman Nose, and Talimena. Plan accordingly.

**OP- CHANGES FOR SBP SCHOOL CERTIFICATIONS**: We are thrilled to tell you there is now a new form and new process for Survivor Benefit Plan School Certifications.

As we shared on the April RSO Quarterly Call, we worked with OSD-P&R to redesign the DD 2788-Child Annuitant's School Certification form and the process to make it simpler. Now, students will no longer need a school official signature or school documentation when they certify, and college students will certify annually instead of each term. The changes will significantly reduce the paperwork burden and make the process easier and more convenient for full-time student child annuitants.

As you know, Survivor Benefit Plan child annuitants who are between age 18 and 22 must regularly certify they are enrolled in a full-time course of education to be entitled to an annuity. In March, we told you that as part of our initiative to make processes and paperwork easier for retirees and annuitants, we tackled the school certification process. At the time, we shared new options for easier certification. Now we have even bigger changes to share: -The school certification form is shorter and simpler, focusing on the student annuitant's future schooling plans. For certifying their past attendance, DFAS will also mail student annuitants a letter with pre-filled information for them to sign. College student annuitants over 18 will only need to certify their full-time attendance once a year during the summer, instead of each term, significantly cutting the paperwork burden. Student annuitants over 18 will self-certify their attendance without the need for a school official signature or documentation from the school, making it quicker and easier for students. If students provide an email address in myPay, we will send an email reminder when they have a school certification coming due. **OP- SUSPENSION OF TRUSTED TRAVELER PROGRAM**: (71 FTW/PA) Effective 27 April 2020, as directed by Headquarters Air Force, Vance AFB will suspend the Trusted Traveler program at the base entry gates. All individuals age 16 and over must have one of the following credentials to enter the installation:

- CAC
- Dependent/Retiree ID
- DBIDS card
- Entry Access List
- State ID + Visitor's Pass

If an individual does not have the listed credentials, they must be sponsored with a pass issued at the visitor control center during normal duty hours, or at the gate after-hours. The earliest dependents may be issued an ID card is 10 years of age, but no later than 16 years of age. The Vance AFB Manpower Personnel Flight is taking appointments for ID cards M-F, 0800-1600. Please call (580)-213-7500 to schedule an appointment.

**OP-MY PAY TRANSITION HISTORY**: myPay now has a Transaction History feature available in your account. Transaction history allows you to view transactions that you have completed within the last 13 months beginning with any transactions you submit today or in the future. The History includes transactions that are "In Process" and transactions that are "Sent to Pay System."

Transactions that are identified as "In Process" have not yet been sent to your pay system and you may cancel the transaction prior to 11:59 pm ET on the day of entry.

Transactions identified as "Sent to Pay System" have already been sent to your pay system for processing. Your pay statement will be your confirmation of what was processed.

At this point, not all myPay accounts have a new Transaction History feature, so if you have more than one type of account in myPay, you may see it in one account type but not another. The Transaction History feature will be added to other types of accounts in the future.

**NP –DRIVERS LICENSE RENEWALS:** In accordance with the OKLAHOMA REAL ID ACT you will need to provide items from the three (3) areas listed below to get a new driver license **effective in July 2020:** 

- 1. You will need to provide proof of identity/lawful presence in the US. The document must be an original or a certified copy. Notarized documents are NOT accepted. Please select **one** (1) **document** from the list below:
- A. State-issued Birth Certificate
- B. Consular Report of Birth Abroad
- C. Unexpired Permanent Resident Card
- D. Unexpired Employment Authorization Card
- E. Naturalization Certificate
- F. Unexpired U. S. Passport
- G. Certificate of Citizenship
- H. Valid, unexpired foreign passport with a valid, unexpired US visa and valid I-94 issued by DHS

Note: If your name is different from the document which is presented from Section One (1) above (due to adoption, marriage, divorce. court-ordered name change), or is not the same on all your documents, you must provide additional documents with legal proof of every name change. Each document must be an original or a certified copy. Notarized documents are not accepted. Please bring one (1) DOCUMENT FROM THE LIST BELOW FOR EVERY name change from your Section One document to your current name.

- A. An official GOVERNMENT-ISSUED MARRIAGE CERTIFICATE/LICENSE
- B. Legal Adoption Paperwork
- C. Court-ordered or legal name change document(s)
- D. Court-ordered divorce decree
- E. A Government-issued death certificate of spouse which includes a connection to your current full legal name
- 2. You must provide proof of your social security number. The document must be an original or a certified copy. Notarized documents are not accepted. Please **select one (1) document from the list below**:
- A, Social Security Card
- B. Current W-2 or 1099 showing FULL Social Security number
- C. Current pay stub showing FULL Social Security number
- 3. You must **provide two (2) proofs of your current Oklahoma address**. Both your name and current residential address must appear on the documents. JUNK MAIL or personal letter will not be accepted. FORWARDED mail will not be accepted. Please bring two (2) documents from the list below:
- A. Copy of previous year's federal OR Oklahoma tax return filing
- B. W-2 wage or 1099 tax form from previous year
- C. Current homeowner or renter insurance policy or statement
- D. Utility bill (electric, telephone (Home or cell), water, sewer, cable, satellite, heating oil or propane provider
- E. Social Security Administration (SSA) document with Oklahoma street address, dated within the last 12 months
- F. Public Assistance Benefit Card and correspondence dated within the last 12 months (not forwarded)
- G. Installment LOAN contract from A Bank or other financial Institution (payday loan company documents are not accepted
- H. Oklahoma high school, college, university or technology center transcript for a current school year or semester

- I. Correspondence from Oklahoma state agency or federal agency with current address, dated within the last 12 months (not forwarded)
- J. Current deed, mortgage, monthly mortgage statement, or a residential lease
- K. Transportation Security Administration (TSA) letter or TWIC card
- L. Current and valid Life insurance or automobile liability policy or card with address
- M. Property tax bill or receipt dated within the last 12 months
- N. Oklahoma motor vehicle title or registration
- O. Oklahoma agricultural exemption permit card (farm tax permit)
- P. Certified copy of court order
- Q. Tribal vehicle title or license
- R. Pilot's License
- S. Valid concealed carry permit
- T. Sales tax or business license
- U. Oklahoma voter registration card
- V. Current documents issued by US military
- W. Current Certificate of Eligibility for Exchange Visitor (J-1) Status (DS-2019)
